Air Sampling for Mold

You may have heard this pitch from environmental laboratories: "Increase your profits by taking air samples for mold... and send them to our laboratory."

In the last five years there has been a race from these laboratories trying to procure lab work from home inspectors. Their underlining motto seems to be, "sample everything and often." This mantra has not gone unnoticed by the larger environmental assessment community and has been fiercely admonished. This backlash over whether sampling should be completed during a home inspection has led many home inspectors to believe that they don't have the right to do mold sampling. Speaking as a person who both does environmental consulting and analyzes samples from home inspectors, I can personally attest that home inspectors can be a perfect "first alert" to water damage/mold issues, assuming inspectors understand when and when not to spend the money to sample for mold.

Samples can be collected either from surfaces or from the air. Each type of sample has strengths and weaknesses. In this article, I'll discuss air samples.

Air samples are collected generally over a 5 to 10 minute period. Using a pump, air is passed through a sampling cassette. Inside the cassette is a thin square piece of glass with a sticky surface. The debris in the air is trapped on the sticky surface. This method of air sample is called a "spore trap". The glass slide is then viewed under a microscope and the number and types of fungal spores are determined.

Air Sample Weaknesses

The levels of fungal spores in the air rise and fall based on air movement. A person can inadvertently disturb one square inch of mold on a cardboard box, collect an air sample in the vicinity, and get an alarmingly elevated level of fungal spores on the air sample. Conversely, a space with very low levels of air movement but with appreciable levels of surface mold can result in an air sample that shows nothing

unusual. To minimize this common weakness, collect the air samples before rummaging through the space in any unusual way. However, the sampler should walk around and simulate typical occupant activities to create a "normal" level of air movement for several minutes prior to conducting air samples.

Another well-known weakness of spore trap samples is the variability in the laboratory analysis. Analyzing air samples that are full of debris is difficult. Published research comparing analyses of the same samples by different laboratories revealed varied results - and some of the results were varied enough to allow different conclusions based on these results. Despite what laboratories will tell you, most large laboratories have strong and weak analysts. For all you know, the analysts looking at your samples may have recently had his heart broken or is thinking of his new car and is distracted. To overcome this weakness, you may consider working with a smaller laboratory where you know the qualifications and maturities of the analysts.

Air Sample Strengths

The two weaknesses discussed have resulted in a significant philosophical pushback against spore trap sampling in the greater environmental community. However, the consultants who understand and adjust to minimize the weaknesses find great use of the strengths of spore trap sampling. Air samples are excellent for determining the presence of non-visible growth on surfaces. Only surface sampling will tell a person where the growth is, however. But for a home inspection, knowing the location of the growth may be less important than first knowing that a potential problem exists, which is answered in part by an air sample. In some situations, air samples can provide evidence of concealed water damage and fungal growth within walls. However, this does NOT work in basements where wind cannot transport the fungal spores from within the walls into the living space.

Spore trap samples can also be analyzed very quickly once the samples reach the laboratory. If you need same day or next day results, it can be possible (if your client is willing to pay the

price) to get the samples to a laboratory very quickly and get the samples put to the front of the line for analysis.

Basic Guidelines of Spore Trap Sampling

The following general guidelines assume you are collecting samples for a general home inspection. Some of the guidelines may not be applicable to an air quality consultant who may be present to do something philosophically different than the role of the generalist home inspector. For the home inspector, spore trap air samples are best used when fungal growth is suspected (based on an odor or site conditions) but the location of the growth is not visually identified. Never collect samples from a room where growth is visible. There is usually no point. Also, never collect air samples to show if someone may or may not get sick in a space.

Based on the experience of Environmental Initiatives staff's analysis of air samples taken by home inspectors, samples collected during the following four situations provided the highest percentage of detecting fungal growth in a space where visual observations failed:

- 1. Basements or homes with a musty odor.
- 2. Slab-on-grade homes that are closed in winter months.
- 3. Cottages or part-time homes.
- 4. Homes with earth crawlspaces.

If you have chosen not to collect spore trap air samples because you were intimidated by the results or unsure of the validity, reconsider. Call or stop into the laboratory of your choice and try to talk to the most experienced or senior person possible. Ask if that person will walk you through interpreting results until you feel more comfortable. Chances are, they will be willing to help. And as a final note, be sure your insurance covers you for collecting biological samples. After all, home inspection is a very litigious occupation.
